Analysis of cases of human rights violations in Gaza according to international regulations and customs

Abstract

Human rights are used during war as a tool to prevent harm to civilians. The Zionist regime has ratified numerous human rights treaties and its actions in the recent Gaza war are a violation of the obligations arising from these treaties; In addition, many international customary rules include the observance of human rights, which is mandatory for everyone, including Israel. Human rights include economic, social, cultural, civil, and political rights, and according to the reports of some human rights organizations, many of its standards have been violated by the occupying regime during the recent war in Gaza. In this article, we want to use a descriptive and analytical method from different aspects of human rights violations in Gaza from the point of view of attacks on medical centers and the injured, siege and imprisonment, forced population transfer, targeting civilians, cutting off water, electricity and fuel. prevent the entry of humanitarian aid, sexual harassment, attacks on schools, mosques and historical places.

1.Introduction

War is one of the problems of human societies, and the efforts of some philosophers, especially during the last century, have been to limit wars with the help of human rights and ethics [1] The sovereignty of governments has been bound by many rules in the shadow of developments in international law, and today the sovereignty of governments is not absolute. And the governments should be accountable for their performance, and one of them is the observance of human rights standards.[2] The three main institutions in the United Nations that were responsible for protecting and promoting human rights are the Security Council, the General Assembly and the Human Rights Commission. The responsibility of the Security Council in this regard is limited to human rights issues that endanger international peace and security. The General Assembly has also adopted a number of resolutions and statements and has held many discussions regarding serious violations of human rights. One of the United Nations institutions that was directly responsible for human rights was the Human Rights Commission, which was established in 1946 by the Economic and Social Council under Article 68 of the Charter, but the success rate of this specialized commission was always discussed by lawyers and politicians until Finally, after 60 years from the date of its establishment, on March 15, 2006, the General Assembly, through a resolution, replaced this commission with the "Human Rights Council".[3] In addition to the institutions of the United Nations, according to the provisions of friendly international human rights, in the event of an armed conflict, both international and domestic, the parties to the conflict are not unlimited in choosing the methods and tools used in war, but rather, the methods of war that cause nonhuman injuries It is forbidden to enter justified; Based on this, that amount of force It must be used, which is necessary to overcome the enemy. The warring parties cannot use any method for war and are prohibited from attacking and bombing unprotected or defenseless places, attacking hospitals, churches, mosques and similar religious places [4].

In international law, there are fundamental rules that are interpreted as mandatory rules. These rules are at the top of the hierarchy of international law, and any other rule that contradicts them is considered invalid, and any government that acts against these rules will have international responsibility.[4] Human rights are among the authoritarian rules, no government or sovereign is immune to it; [5] although the government can both guarantee human rights to its citizens and violate them to its own citizens and other nations. be.[6]

The actions of the Zionist regime in the land of Palestine must be in accordance with the customary rules of international law as well as international human rights treaties of which the Zionist regime is a member. Some of the treaties in which the Zionist regime is a member include: International Covenant on Economic, Social and Cultural Rights; The International Covenant on Civil and Political Rights, the International Convention on the Elimination of All Forms of Racial Discrimination, the United Nations Convention on the Elimination of All Forms of Discrimination against Women and the Convention on the Rights of the Child. In wars and military attacks, in order to prevent the violation of basic human rights, the protection of human rights must be strengthened, and this is possible only if the governments consider themselves obliged to observe minimum standards for human beings in any situation. . The human rights committee in the interpretative theory number 31, while stating the complementary relationship between human rights and humanitarian rights, has emphasized the implementation of the International Covenant on Civil and Political Rights in the conditions of armed conflicts, which are governed by the rules of humanitarian rights. The Human Rights Committee considers the member states to be responsible for guaranteeing the observance of the Covenant for all persons under jurisdiction or under control. The Covenant of Economic, Social and Cultural Rights has also established explicit limitations in relation to territorial jurisdiction, and based on this, the occupying regime is committed to complying with its provisions towards the Palestinian people, because according to Article 4 of the Covenant of Economic, Social and Cultural Rights, the member countries They cannot subject the mentioned rights to restrictions except according to the law and only to the extent that is compatible with the nature of these rights and its purpose is exclusively to develop public welfare in a democratic society. According to the Committee of Economic, Social and Cultural Rights, the restrictions It should be proportionate and governments should adhere to their obligations according to customary international law. It should be said that the principles contained in the United Nations Charter reflect customary international law to some extent. The court has emphasized that the occurrence of conflicts does not negate the protections contained in the Covenant of Civil and Political Rights and the Covenant of Economic, Social and Cultural Rights and the human rights obligations of governments according to them, and in this regard it refers to Article 4 of the Covenant of Civil and Political Rights. according to which, under any circumstances, including the occurrence of conflict or emergency, governments are not allowed to suspend some of the basic human rights. In this case, although Israel has said that it observes the international humanitarian laws contained in the Fourth Geneva Convention in the occupied territories[7], the Zionist regime has failed to fulfill its obligations under various pretexts. The international community has complained in accordance with human rights and humanitarian rights in the occupied Palestinian territories. This regime claimed that the Covenant of Civil and Political Rights and the Covenant of Economic, Social and Cultural Rights, which Israel has also signed, are not applicable in the occupied territories because the main purpose of these human rights treaties is to protect individuals against their respective governments. It is also considered in peacetime. In this case, regarding the nature of the rules of human rights, the Court declares that the protections stipulated in international human rights treaties do not stop during war and governments must respect the rights of human beings both during peace and during war. And it was on this basis that the action of the occupying regime to build a retaining wall in the occupied lands was declared a serious violation of the human rights of the people living in that area, including the right to choose residence, the right to move freely.[8]

The Human Rights Council has always tried to take clear positions on Israel's criminal and antihuman rights actions, but due to the politicization of the United Nations Security Council, the actions and activities of this council have little effect on anti-human rights behaviors. The Israeli regime has not. The negative or abstaining opinions of some of the member states of the Human Rights Council are also inconsistent with the sensitivity they show regarding the importance of observing human rights[9] and in the shadow of these neglects and politicization of the relevant institutions, Israel is at ease. He has committed all kinds of gross violations of human rights in Gaza, which we will mention in the rest of the article:

2. Encirclement and confinement

The blockade of the Gaza Strip refers to the blocking of the borders of the Gaza Strip since June 2007 by Israel and Egypt, which was done with the aim of putting pressure on the Hamas government. Since the siege of the Gaza Strip, the borders of the Gaza Strip have been closed to international aid organizations and foreign journalists. On January 24, 2008, the UN Human Rights Council asked Israel to end the blockade of the Gaza Strip in order to reduce tension. Since November 5, 2008, Israel has completely cut off the communication of 1,500,000 Palestinians with the outside world by closing the crossings of the Gaza Strip. The special rapporteur of the United Nations Human Rights Council, Richard Falk, called the continued blockade of Gaza a crime against humanity and collective punishment of the Palestinian people. He criticized Israel by saying that Israel only allowed aid when the people of Gaza were on the brink of famine. Due to the control of the Gaza Strip by Hamas, Israel labeled this region as "enemy land" and announced that it would stop delivering diesel and gasoline to Gaza. It will decrease by 15%, but fuel delivery to power stations will not decrease. Israel argued that with Gaza declared under the control of the enemy, Israel no longer has to comply with the international laws governing the administration of the occupied territories and provide the public services needed by the civilian residents of the area, but some time later, it completely stopped sending fuel. After this stage, it was time to completely cut off the fuel of the only power plant in Gaza. Since the Gaza Strip's only power plant ran out of fuel, the area's electricity has been out for several hours every day. Israel stated that the reason for this action was to stop Hamas from launching rockets towards Israel. The United Nations Office for the Coordination of Humanitarian Affairs in Gaza reported that in 2008, half of the equipment at Gaza's Shafa Hospital was out of order due to lack of energy and spare parts. According to Oxfom, the supply of drinking water has also faced problems and due to the lack of access to chlorine, it was impossible to treat it since mid-December. In this difficult situation, in November 2008, Israel opened the crossings of Gaza only 4 times for the passage of 140 trucks carrying humanitarian aid. According to Oxfom, this was only 8% of the aid sent by the international community to the Palestinian people.

The people of Gaza, who have been under siege for the past 16 years, have been the target of the Zionist regime's collective punishment strategy for more than 4 months. In response to more than seven decades of crimes committed by the Zionist regime, the Palestinian resistance groups launched the "Al-Aqsa Storm" operation from Gaza (southern Palestine) against the positions of the Israeli regime on October 15, 2023, which finally, after 45 days of fighting and fighting, On December 3, 1402 (November 24, 2023), a four-day temporary truce was established, or a pause for the exchange of prisoners between Hamas and Israel. This pause in the war continued for seven days, and finally on the morning of Friday, December 10 (December 1, 2023), the temporary ceasefire ended. arrived and the Israeli regime resumed attacks on Gaza. In order to retaliate against the "Al-Aqsa Storm" attacks and compensate for its failure and stop the resistance operations, this regime has closed the crossings of the Gaza Strip and is bombarding this area. The closing of the crossings is done on the people while according to Article 12 of the Covenant of Civil and Political Rights, anyone who legally resides in the government land has the right to freely

pass and freely choose his residence there. Everyone is free to leave any country, including his own country.

After the blockade of Gaza, the unemployment rate increased, trade was disrupted, and the price of many goods tripled or quadrupled, and the only way to provide food and necessities for the people was the humanitarian aid of other nations, and the smuggling of goods such as cigarettes, clothes, chocolate, fuel, etc. Drugs from Egypt to Gaza Strip have brought a lot of profit to the smugglers. This is despite the fact that employment is recognized as a human right in many international documents. According to this right, every human being has the right to benefit from desirable and worthy job opportunities.[10] For the people of Gaza, despite being surrounded and imprisoned, the implementation of this right has been limited and even impossible in many cases. In addition to the siege regarding the imprisonment of the people of Gaza, the Islamic Republic News Agency, citing the American newspaper Washington Post, reported the arrest of hundreds of Palestinian civilians by the Zionist regime's army in Gaza and their transfer to prisons of this regime inside the occupied territories. Destruction of hospitals or targeting ambulances and medical personnel are among the violations that carry the responsibility of the Zionist regime as a member of the Covenant of Economic, Social and Cultural Rights.[8]

During the recent war in Gaza, medical and health facilities are very limited. A large number of people suffered serious injuries from the direct attacks of the Zionist regime. On the one hand, severe lack of medicine and failure of existing vital equipment due to the siege of hospitals and insufficient power reserves in the network, on the other hand, have threatened people's health. The Palestine Red Crescent Society expresses its deep concern regarding the violent attacks by the occupation forces on medical missions and vehicles carrying the wounded, which lead to intolerable consequences for the medical forces, the wounded and the sick .

This is despite the fact that employment is recognized as a human right in many international documents. According to this right, every human being has the right to benefit from desirable and worthy job opportunities.[10] For the people of Gaza, despite being surrounded and imprisoned, the implementation of this right has been limited and even impossible in many cases.

The Palestinian Red Crescent reminded the international community that in accordance with the Geneva Conventions, their additional protocols and international humanitarian law; Medical forces, transports related to medical matters, wounded and sick are protected.[11] According to Mehr News Agency, in the letter of Mr. Kolivand, the head of the Red Crescent Society and the head of the National Humanitarian Rights Committee of Iran, regarding the violations of international humanitarian law in Gaza, to the prosecutor of the International Criminal Court, there are cases such as attacks on civilians, hospitals and medical workers. It was mentioned and emphasized that it is expected that the International Criminal Court, as a judicial institution, will take steps towards the realization of justice for everyone everywhere, and that as soon as possible, the necessary measures will be taken to try those who commit international crimes listed in the Rome Statute during the armed conflict between have become internationalized in his agenda.[12]

4. Forced population transfer

In relation to the right to housing, certain actions during the war - especially the widespread destruction of houses - are considered forced evictions and as a result, violation of Article 11 of the Covenant of Economic, Social and Cultural Rights. The Economic, Social and Cultural Rights Committee has stated: "Forcible eviction is the permanent or temporary removal of individuals, families or groups from their homes or lands against their will." The Minister of Information of the Zionist regime is the last person to suggest " has provided voluntary settlement of Palestinian refugees in Gaza; He wrote in "Jerusalem Post" that instead of paying for the reconstruction of Gaza or the failed UNRWA, the international community could help with resettlement costs and help the people of Gaza build a new life in their new host countries. [8] On October 14, 2023, the Israeli army ordered the evacuation of northern Gaza for all of Gaza City to be evacuated to the south within 24 hours; Shortly after the evacuation order was issued, UN facilities, including UNRWA, were ordered to move to Rafah. The Israeli evacuation order was described by Jan Eglund, a former Norwegian diplomat involved with the Oslo Accords, as a forced population transfer. "Forced transfer" is the forced transfer of a civilian population as part of an organized crime against it and is considered a crime against humanity by the International Criminal Court. "Hundreds of thousands of people are fleeing for their lives. This is not what you can call an evacuation." Eggland said in an interview with the BBC. This is the forced transfer of people from all over northern Gaza. According to the Geneva Convention, it is a war crime. UN Special Rapporteur Francesca Albanese warned of mass ethnic cleansing in Gaza Israeli historian Raz Segal called it "a textbook case of genocide"

.5. The goal of Qaradadan is irregular

He transgressed and carried the regime of Israel into Mardam, Gaza, and an irregular group of people, without hesitation, he flagrantly violated coercive rules and created a group of crimes among the militias. Implementing balances and rules of rights among the sects, including customary rules, rules, and regulations Rights in Shardostana among the sects, a Zionist religious who committed an obscene and serious violation of the previously mentioned decisions. On the basis of the rules of customary rights and decisions between the sects, the perpetrators and those who violate these decisions, the reason for the commission of the crimes of Chinggi and the Neslikshi of Shunde trials and punishments is required.[4]

Attribution among the people who have access to it is a security policy and a protocol that is attached to it, especially people who have been protected for a long time, and who are armed with the actions of Israel, such as an obscene violation of human rights in Bashardostana, which receives Kurdistan.
